Why do a fall burndown application with residual?

- Effective control of winter annuals and biennials
- Workload shifting from spring to fall to reduce spring time crunch
- Cleaner, drier, warmer fields to ensure early planting in a superior seedbed
- Residual keeps fields clean until planting
- Reduces insect pressure, especially Black Cutworm

Corn or Soybean: Fall Burndown

Elevore: 1 oz/A + 2,4-D

Or

Enlist One: 32 oz/A

**add glyphosate for grass control

Soybean: Fall Burndown+ Residual

Canopy DF: 3-4 oz/A

*All applications require 2,4-D/Dicamba for proper burndown

**Add glyphosate for grass control

Corn: Fall Burndown + Residual

Basis Blend: 1.25 oz/A

or

SureStart II: 1 pt/A

*All applications require 2,4-D/Dicamba for proper burndown

**add glyphosate for grass control
