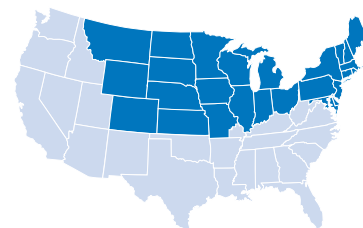

 1. Prepay Cash and Prepay Credit Savings are available for qualification from Oct. 1, 2020 through Feb. 26, 2021. Spend your TruChoice Prepay account funds at any participating retailer; transactions must be entered into TruChoiceOnline.com between Nov. 18, 2020 and Sep. 30, 2021.
 2. Any amount of funds towards your Corteva Agriscience™ Crop Protection products can be financed or prepaid; however a minimum of at least \$7,500 of qualifying products must be reached to receive the crop protection prepay savings.

TruChoice® Financing

The TruChoice Financing program enables customers of Corteva through its subsidiary PHI Financial Services, Inc., to finance their approved crop protection product purchases. Cash can be applied to a registered TruChoice Prepay account to avoid loan approval.

- Select Savings will not be applied to Corteva Cash transactions
- Select Savings will be realized prior to prepay percentage being applied.

Corteva™ Cash for reported purchases without prepay

All qualified purchases outside of TruChoice will earn Corteva Cash reward for the following season, with the exception of Sonic, which can only participate with Prepay Savings

- Purchase eligible products from a Grower Point of Sale (GPOS) reporting retailer between dates of Oct. 1, 2020 - Sep. 30, 2021
- Retailers must submit their GPOS data via Data Dimensions or other supported data reporting systems by Oct. 15, 2021.
